Requirements for Entering:

1. Exhibitors must read and comply with all **Fair Rules and Regulations**, located on page 4, for participation in the Woodstock Fair.
2. Department 21 is open to amateur exhibitors only.
3. Judging will be by the Danish System, except where otherwise stated.
4. Substitutions will not be permitted on the registration form.
5. **Exhibitor's name and address must be prominently displayed on the back of each entry.** No names may be shown on the front, as judging is completely anonymous.
6. Entries will be displayed, space permitting. Large items may be restricted.
7. Any entry not complying with the specifications may be accepted, but not judged and/or disqualified and will only be exhibited if space allows.

Photography:

8. A **maximum of two** photograph entries, in addition to the Fair Contest, per exhibitor will be accepted.
9. **Photographs must be 5"x7" and matted, to equal the overall dimensions of 8"x10" including the mat.**
10. Photos must be securely mounted on a 2 or 4 ply mount board or foam core, color of your choice. **Double matting is not permitted.** One picture per mat; multiple pictures per mat will not be accepted.
11. No printed numbers, such as dates or names are permitted anywhere on the front of the photograph or matting.
12. No hangers, glass or wood frames will be allowed. Please be advised that Velcro will be affixed on the back of each matted photo for display purposes.

Painting:

13. A maximum of 5 paintings per exhibitor will be accepted. Paint-by-number pictures will not be accepted.
14. Paintings are not required to be framed but need to be able to be hung. A wire must be securely strung across the back of the painting.

Contest Rules

- Official entry forms will be on the Association of Connecticut Fairs webpage. www.ctagfairs.org
- This contest is open to all persons regardless of age. Professional photographers are not eligible. The photo submitted must be taken by the person entering the contest.
- There will be no entry fee to enter this contest. The Association of Connecticut Fairs will not be responsible for any lost or damaged photos submitted to the contest.
- The photographer's name, date, photo title and location of where each photo was taken must appear on the reverse side of each photo.
- Each exhibitor may enter a maximum of two (2) photos in each lot.
- A photo taken cannot be entered in more than one lot.
- Salon Print exhibitors cannot enter Snapshot contests.
- Exhibitors must enter as “adult” or “junior”. Juniors cannot enter as an adult.
- All entries must be submitted no later than 6 pm Saturday, October 2, 2021, to any of the committee members. All entries become the property of the Association of Connecticut Fairs.
- Contest winners will be announced at the Annual Fall Meeting and Banquet. Please visit www.ctfairs.org for the date, time and location of the meeting.
- In the event that less than ten (10) prints or snapshots are entered in either the black & white or color lots, the two lots will be combined and only one set of awards will be made. Awards will be given at the judges’ discretion if the number of entries does not justify the five (5) awards.
- The Association of Connecticut Fairs reserves the right to reproduce any and all entries with the photographer's by-line. One photo may be chosen to appear on the cover of the Association of Connecticut Fairs booklet from the previously judged contest winners.
- The overall contest winner will receive one (1) Reduced Rate Ticket for the upcoming fair season.
- A photo contest will be held at the Annual Fall Meeting and Banquet in which all registered meeting attendees will vote to determine the winner.
